- a. Jackie Young; Dakota County Opioid Response Committee

Jackie Young, a member of the Dakota County Opioid Response Committee and a mother who tragically lost her 30-year-old son to an unintentional opioid-related death, met with Commissioners to discuss the dangers of non-prescription drug use and the risk of accidental overdose. She emphasized that Narcan is available at the local library and can save lives. Mrs. Young also informed Commissioners about an upcoming event on Monday, February 2, 2026, at Rosemount High School and extended an invitation for them to attend. Additionally, she asked for their feedback on the most effective ways to engage high school students in this critical conversation.

b. Leadership Talk; Being a Leader in Hard Moments

Mayor Weisensel guided Commissioners through a worksheet titled *“Being a Leader in Hard Moments.”* The discussion focused on strategies for handling setbacks, leading by example, and using quiet leadership to positively influence the mood. Commissioners explored the importance of authenticity, humility, and the distinction between being liked versus being respected.
